Women's Equality Day Celebration

The Women's Equality Day celebration will feature a nonpartisan speaker with unique insights into the challenges of democracy and leadership in 2024. One or more women community leaders will be honored for their contributions to advancing equity for women. [2023 awardees included Fort Collins City Councilor Julie Pignataro for her work to create an Equity Office, get taxes removed from menstrual products, and help pass a city ordinance that prohibits discrimination; former Loveland City Council candidate Caitlin Wyrick for her work with Heart and Sol to promote diversity in government and increased participation from under-represented groups; and Barbara Hansen of Loveland, past Larimer League's Voter Services Team leader]. In addition to sponsorships and ticket sales, a silent auction will be held to raise funds. One hundred guests are expected to attend the August 22nd event.

The League of Women Voters of Larimer County is a member of the national League of Women Voters, formed when women gained the right to vote in 1920. Throughout the League's more than 100-year history working in all 50 states, our focus has been to expand participation and give a voice to all Americans. We empower voters and defend democracy through advocacy, education, and litigation, at the local, state, and national levels.
